Our aspiration is for the whole of the ancient Ridgeway, from coast to coast, to be recognised, valued, protected and promoted as a pre-eminent facility for walkers and other users.

## Our Vision for The Ridgeway:

- A place where people can exercise, enjoy their special interests and a memorable day out, respecting the Countryside Code;
- Properly maintained, with excellent access, signage, facilities and information, not over-used or abused, benefiting everyone.

**Our Role:** To campaign for the protection of The Ridgeway, working with the Ridgeway Partnership and others to promote its value to the whole community as an essential part of everyone's life and heritage; and to represent any concerns about The Ridgeway to those responsible for its maintenance.

We seek to engage people living near to and using The Ridgeway in activities that spread knowledge and appreciation of its historic, artistic and environmental features.

We will participate in and work with the Ridgeway Partnership and other relevant organisations to develop The Ridgeway as a vital part of the National Trail network.



## From the Chairman

Dear Friends,

Dear Friends,

This time last year, in my first Chairman's letter, I noted that *"Spring is coming – snowdrops have been in flower for some time and daffodils are appearing, no doubt to put on their usual spring show before the AGM."* Since that time, as the seasons came and went, issues relating to the Ridgeway have come and gone, some threatening the trail, some offering hope in new activities.



This year then, my first full year in post, has been a busy and informative one for me, as I get to grips with all the challenges confronting us in ensuring the proper preservation and promotion of the Ridgeway. This task now involves working within the Ridgeway Partnership as well as on our independent efforts and concerns.

As your representative on the Partnership, I have engaged fully with all our colleague agencies, and tried with them to address the increasing financial challenges as the Natural England grants for National Trails come under question. I welcome moves for the National Trails to work in alliance to protect their position. I am relieved to report that the grant for the Ridgeway for 2017/18 has now been confirmed at the same level as last year, but the

reducing trend will continue. Trails will have to seek resources elsewhere, increasing revenue from sponsorship, donations or commercial activities, and seeking grants for new projects such as the plan to improve strategic access routes to the Ridgeway from local communities. The Partnership has set up a new Fundraising Group that I have joined. One contribution by the Friends is to agree a process whereby we may receive donations sourced by the Partnership and apply them, at our discretion, for the benefit of the Ridgeway. Your Secretary and I also attend the Partnership's Promotion and Development Group, for which we are pursuing the Creative appeal of the Ridgeway.

Representing the Friends of the Ridgeway, I was invited to join the Motoring Stakeholder Working Group initiated by Natural England, to meet with other stakeholders of the National Trails to debate issues associated with motor vehicles on byways. Whilst the Ridgeway is largely protected – and there may be some more good news in due course – damage to the trails by motor cycles and 4X4s continues. The Department of the Environment has made it clear that for several years there will be no new legislation. However, the Group has been set the task of trying to establish some sort of guidance or code of good practice that can be used in establishing local agreements. I have to say that the two sides hold very established views and any joint guidance seems a long way off; reporting back after the first meeting I commented that it was like the battle between the Capulets and Montagues. Maybe it is a case of better to travel hopefully than arrive.

Within our own Association I have been pleased to meet as many of you as possible, particularly in the forum of the Vale of White Horse Local Group, whose excellent events I have regularly



attended – and recommend. I do hope that members in other areas may wish to follow their example, and form Local Groups. We would be pleased to support such initiatives. I have also sought to energise our member



recruitment efforts. Although our mail-shot to members this year has so far had limited results it is important for this work to continue. We need to engage with both the long-term and new residents near the

Ridgeway, and to make them aware both of the attractions of the Ridgeway and its environment and of the need to protect it. We also now urgently need a new team to join me on the Committee and to take our efforts forward. Our effectiveness is increasingly threatened by the lack of volunteers for this important work, and I hope that anyone who can spare some time will put their names forward.

Our major new initiative this year has been the launch of the Swire Ridgeway Art Prize, funded by a generous gift by a member and long-standing supporter. The entries will be exhibited in the Thomas Hughes Memorial Hall, Uffington, over the weekend of 22-23 April, 2017, prior to the awards and our Annual General Meeting. I do hope that as many members as possible will come along to visit the exhibition and attend the meeting.

**The Ancient Ridgeway:** An ancient trade route, perhaps our oldest road, dating back 4,000 years at least to the civilisation that built Avebury and Stonehenge, the ancient Ridgeway follows the edge of the chalk escarpment across the South of England, from The Wash to the coast of Dorset. Coupled with the Icknield Way lower down the slope, just above the spring line, the well-drained and lightly wooded track, above the marshes and thick woods of the Vales, linked Seahenge and Grimes Graves in Norfolk, to Avebury and Stonehenge. Burial mounds and hill-forts, and hill figures carved in the chalky



turf, may be traced along the route, and armies have marched and fought along it. Its powerful atmosphere and its glorious countryside still today inspires and stimulates artistic creativity.

**The Ridgeway National Trail:** It was only natural that, when the National Trails were established after World War II, The Ridgeway should take its place amongst these premier routes. Only the central section of 87 miles between Ivinghoe Beacon in Buckinghamshire and Overton Hill near Avebury in Wiltshire has yet been so designated. However, this section of The Ridgeway brings together the best of the Chilterns and the North Wessex Downs, joined by the picturesque Thames Valley. Virtually the whole route is within either the Chilterns or the North Wessex Downs Areas of Outstanding Natural Beauty (AONBs).

The Ridgeway today provides an wonderful experience not only for walkers and local residents, but for visitors and families seeking the best of rural England. South of the river lies the classic, high, down-land track, with its massive views above the Vale of White Horse, and to the north the woods and vales of the Chiltern hills harbour pretty villages and welcoming pubs and restaurants.

## **The Ridgeway Partnership**

The Ridgeway Partnership, established in 2015 as one of the new family of National Trail Partnerships instigated by Natural England, has taken on responsibility for the management, promotion and improvement of the Ridgeway National Trail. The Ridgeway Partnership brings together the local authorities along the route, the Chilterns and North Wessex Downs AONBs, the Ramblers, Chiltern Society, and other stakeholder representatives. The Friends of The Ridgeway is a founding Partner, and played a significant



role in setting up the Partnership. Oxfordshire County Council, as Lead Partner, holds funds and accounts, hosts a Ridgeway Officer, Sarah Wright, and other part-time staff, and supports the corps of dedicated volunteers who, assisted by Chiltern Society teams, carry out the regular maintenance needed to ensure the high standards required of National Trails. Natural England provides a grant towards core costs, alongside lesser amounts from local authorities, and co-ordinates the National Trails network as a whole.

The Ridgeway Partnership seeks to work closely with landowners and local communities in order both to ensure high standards of maintenance of the Ridgeway as an important recreational and leisure facility for a wide variety of users, and to raise awareness of its unique heritage and environmental





characteristics. The Ridgeway has considerable potential to increase economic benefits from tourism, to improve physical and mental health, and to provide inspiration for creative activity in many fields. The Partnership has identified five themes for the promotion and enhancement of The Ridgeway, building on aspects of its unique appeal. These themes, listed as the Natural, Living, Ancient, Sporting and Creative Ridgeway, will highlight its wild-life and bio-diversity; the superb landscape and scenery; good food, country pubs and services; sporting events and family

recreation; its wealth of heritage and pre-history; and its role as an inspiration for art and literature, or just peace and quiet.

A major initiative during 2017/18 will be the launch of a plan to improve a number of strategic access routes between local communities and the Ridgeway, providing clearer signage, better surfaces, easier accessibility and improved information, encouraging residents to make more use of the Ridgeway, and Trail users to benefit from local services and attractions. Other improvements will see development of the National Trails web-site and availability of mobile phone applications to offer more information on the route and services.

The need for economies in public services generally is having an increasing effect on the Ridgeway and the National Trails network as a whole, as core grants are reduced or remain static. National Trails Partnerships, the Ridgeway amongst them, will in future need to mobilise new resources in order to fund new initiatives and promotions, and to ensure that high standards of management are maintained.

## The Swire Ridgeway Arts Prize

With the help of a munificent donation from a generous supporter, the Committee has been able to implement a long-standing ambition to launch an Arts Competition and Prize, celebrating the creative and artistic inspiration of the Ridgeway. It is hoped that, if shown to meet a need, the competition will be repeated annually. Separate classes are open to works of painting, photography, sculpture and writing (poetry or prose). Prizes will be awarded for each category as well as to an overall winner, each winner receiving a cash sum and a keeper prize. Worthy entries will be displayed at an Exhibition over the weekend of the Ridgeway Friends Day and Annual General Meeting. This year's event will be held in the Thomas Hughes Memorial Hall in Uffington, over the week-end of 22<sup>nd</sup> and 23<sup>rd</sup> April., 2017. The Exhibition will be open to the public between 10.00 am and 5.00 pm each day, and the Prizes will be awarded at 3:30 pm on Sunday 23<sup>rd</sup> April.

## The Friends of The Ridgeway: The Facts

The Friends of The Ridgeway is a voluntary association, founded in 1983, and now a registered charity, no 1107926.

**The President and Vice-Presidents:** Our current President is Lord Bradshaw. Our seven Vice-Presidents are all Members of Parliament whose constituencies include sections of The Ridgeway.

**Volunteer Committee:** The Trustees of The Friends of The Ridgeway, elected annually to run the Association, comprise an Executive Committee, which normally meets quarterly, and is supported by other volunteers, including our valued Planning Adviser. The Committee, listed on the back cover, includes the Chairman, Secretary and Treasurer. We are currently seeking to recruit a new Secretary, Treasurer, and new Trustees with special responsibility for Membership, Communications and Engagement with the local community and other organisations. Trustees also represent their local areas. Anyone able to help is encouraged to apply to the Secretary.

**Meetings:** The Association meets in Annual General Meetings of members, at which Officers and Trustees are elected, and the Annual Accounts and Trustees' Report are considered and approved. The Accounts, prepared by the Treasurer, are scrutinised by an Independent Examiner and reported to the Charities Commission. Our Annual General Meeting will be held this year in the Thomas Hughes Memorial Hall in Uffington, on Sunday, 23<sup>rd</sup> April, 2017, at 3.00pm.

**Activities:** Our initial task was to challenge the damage being done by cross-country vehicles to The Ridgeway and other green paths, and to campaign for control of the abuse by restricting access. This was largely achieved by the 2006 Natural Environment and Rural Communities Act (NERCA), and the application of Restricted Byway status to most of The Ridgeway National Trail south of the Thames. We continue to press for the remaining sections in Wiltshire to be so classified.

**The Swire Ridgeway Arts Prize:** We have launched this year a competition celebrating the Ridgeway as a creative inspiration for artists. An Exhibition of entries and the Prize awards will be held during the course of a Ridgeway Friends Day in April 2017. Details are given above.

**The Ridgeway National Trail:** The National Trail network is overseen for Government by Natural England, which provides grants for maintenance, and for a National Trails web-site and other promotion. Following a Review, a new Ridgeway Partnership was formed from March 2015, with Oxfordshire

County Council as the Lead Partner, to take responsibility for its operations. A dedicated Ridgeway Officer has been appointed. We have as a founder member engaged fully with this new Partnership, and will continue to work closely with it.

**The Great Stones Way:** In pursuance of our aspiration to re-create the ancient Ridgeway from coast to coast, the Association proposed The Great Stones Way, as an extension of The Ridgeway southwards to Old Sarum, over existing rights of way linking Avebury and Stonehenge. We have been unable to complete way-marking through the Vale of Pewsey due to local opposition. However, a Guide-book has been published by Cicerone, and we are encouraging formation of a local group to assume responsibility for its future development and promotion.

**Future Concerns:** We shall campaign to make sure that the Ridgeway Partnership has the resources of staff and funding to operate effectively, and to maintain, enhance and promote The Ridgeway. We shall continue to report damage and misuse of the Trail, and to press for reinstatement. We shall work with the new Partnership and our Planning Adviser to review planning applications affecting The Ridgeway, and oppose development proposals likely to damage its unique environment.

**Local Groups:** We encourage the formation of local groups of our members within communities, undertaking activities and events of interest to residents, and relevant to The Ridgeway and its environment. The first such group in The Vale of White Horse has blazed a trail and we hope that it will be followed by others all along the line of The Ridgeway.



**Communications:** We operate an informative web-site, [www.ridgewayfriends.org.uk](http://www.ridgewayfriends.org.uk), which is available to promote our own activities and those of our many associate organisations. We publish a quarterly Newsletter, now, in the face of escalating postal costs, in an electronic format. We are also making efforts to develop our presence in social media; follow us on Twitter.

- 1 Financial balances:** The financial balances for the year ending 31 December 2016 were:

The Funds allocated to GSW remain static at £4,194, with no further expenditure in the year. A donation of £2,000 was received for the express purposes of the Ridgeway Partnership.

- 2 Independent examination of the 2016 accounts:**

The accounts have been examined, as in previous years, by Steve Sherman and I am pleased to report that he has given them a clean bill of health. Copies of the signed accounts have been lodged with the Charities Commission.

- 3 Membership subscriptions:** The number of membership payments continuing to come in via our Lloyds Bank account has reduced significantly, due to a number of reminders being sent, asking them to switch their standing orders into our CAF account (from £650 last year to £200 this year). The Lloyds account will remain open however, until we can get all standing orders switched to CAF. A total of £2,453 was received for subscriptions and £4,159 for donations (including the £2,000 for Ridgeway Partnership purposes). At 31 December our membership numbers were 160 paid and 282 Life Members – 442 in all.

- 4 Gift Aid:** The amount to be claimed from HMRC was £586 and was paid over in January.

- 5 General:** It has been another good year financially for the Friends. Finances are now back on a firm footing but the main emphasis, as witnessed by the membership drive during the latter part of the year, is on numbers. Unfortunately, the membership drive has so far only resulted in 16 new memberships.

Our website now contains a membership application form, which can be downloaded and printed for posting to us, or it can be completed online and emailed to us. We have a new webmaster, Ricky Cunningham, who is concentrating on improving the website in order to make it more informative and customer friendly.
